## Annual General Meeting & Association Board Elections

The Friends of the Dana Point Library will hold its Annual General Meeting in the Community Hall of the Dana Point Library at 33841 Niguel Road on Wednesday 19 February 2014 at 5:00 pm, to elect seven new Directors to the Association Board. The four candidates with the highest vote counts will serve for two years (2014 & 2015). The other three elected directors will serve for one year (2014).

We are delighted to announce that the County of Orange has decided to proceed with the refurbishment of the Dana Point Library's skylights. The *Friends* have already committed \$70 000 (a majority share) to the project; the County will fund the rest of the budget.

Renovations are expected to begin shortly, and we anticipate that the project will be complete by mid-2014. The new skylight funding demonstrates our intent to set and achieve specific goals that benefit the Dana Point Library. The new Board will continue in the same spirit during 2014.
